SETUP AND OPERATION

Thank you for purchasing a Phoenix R250 LGR Dehumidifier. Please follow these steps to successfully setup and operate your new dehumidifier. For a complete manual, scan the QR Code.



STEP 1

Plug your dehumidifier into a 110V outlet.

STEP 2

Connect your condensate hose to your dehumidifier and place the other end into a drain, sink, etc. The connection for the condensate hose is located under the inlet cover on the top of the machine.

STEP 3

Turn on the power switch.

STEP 4

The compressor will turn on, and the unit will start dehumidifying.

AFTER THE JOB

Press and hold the purge button until water is no longer flowing out of the unit.

Turn the power switch off. Unplug the dehumidifier.

Disconnect the condensate hose and remove any excess water.

YEAR ONE: Therma-Stor LLC warrants that, for one (1) year the Phoenix Dehumidifier will operate free from any defects in materials and workmanship, or Therma-Stor LLC will, at its option, repair or replace the defective part(s), free of any charge.

Year(s) Two Through Five: Therma-Stor LLC further warrants that for a period of five (5) years, the condenser, evaporator, and compressor of the Phoenix Dehumidifier will operate free of any defects in material or workmanship, or Therma-Stor LLC, at its option, will repair or replace the defective part(s), provided that all labor and transportation charges for the part(s) shall be borne by the end-user.

ROTOMOLD DEHUMIDIFIERS ONLY:

YEAR(S) ONE THROUGH SEVEN: Materials and workmanship of the housing are covered.

CONDENSATE PUMP: Units manufactured with the rotary-style condensate pump have a three-year warranty on this pump. Therma-Stor LLC warrants that, for three (3) years, the condensate pump will operate free from any defects in materials and workmanship, or Therma-Stor LLC will, at its option, repair or replace the defective part(s), free of any charge.

ADDITIONAL INFORMATION FOR ALL DEHUMIDIFIERS:

End-User Responsibilities: Warranty service must be performed by a Servicer authorized by Therma-Stor LLC.

If the end-user is unable to locate or obtain warranty service from an authorized Servicer, he should call Therma-Stor LLC at the above number and ask for the Therma-Stor Service Department, which will then arrange for covered warranty service. Warranty service will be performed during normal working hours.


